New Mexico is home to world-class research institutions and universities, including 2 Department of Energy National Labs (Sandia and Los Alamos).

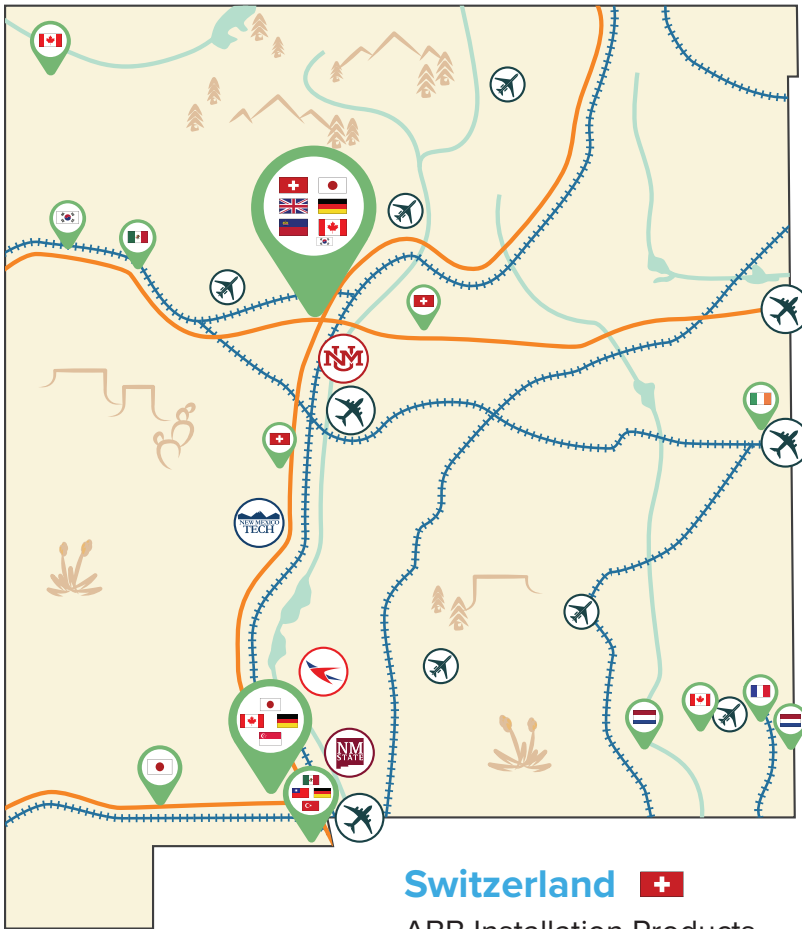
