

RENEWABLE ENERGY PROGRAMS

PNM offers a suite of programs, created in partnership with our customers, to help them meet their renewable and sustainability goals.

PNM SOLAR DIRECT

Capacity subscription, customer pays for cost of renewable resource and receives credit for fuel, Renewable Energy Rider, taxes and other fees associated with the energy produced by the renewable facility.

PNM SKY BLUE

kWh block subscription or percentage of energy consumption subscription, customer pays a fee of 1.7 cents per kWh according to subscription level; receives credit for fuel and renewable rider, taxes and fees according to subscription level.

PNM GREEN ENERGY TARIFF

Rate 36B was designed to provide competitive pricing for customers interested in dedicated, renewable power.

PNM GREEN ENERGY RIDER

Rider 47 is the companion
Rider to the Green Energy
Tariff. This Rider allows
green-minded customers
to add incremental green
resources to the grid while
maintaining affordable
rates.
