

Major labor pulls come from NM border state, Texas. Major population centers are Lubbock and Midland with populations of over 330,000.

Hobbs, New Mexico is home to CTECH, a Career and Technical Education Center at Hobbs Municipal Schools. The \$50 million facility provides courses that prepare area students for technical careers after completing high school. CTECH strengthens Lea County's future of workforce.

Hobbs is also home to the NMJC Workforce Development center. Workforce Development offers customizable courses tailored to specific industries to strengthen the workforce in existing businesses

Success Stories





In April 2021, FlexSteel USA, a provider of cut-to-length flexible oilfield pipe, opened a small satellite location in Hobbs, NM with two employees. The operation steadily grew to approximately 60 employees by the end of 2022.

In 2023, FlexSteel located all Midland operations to Hobbs, resulting in an FTE of approximately 100 employees.

FlexSteel has also explored the possibility of expanding its current footprint to include a manufacturing operation, which would produce its largest diameter pipe to Hobbs to be distributed nationally and internationally.


Lea County stands out for its abundance of available land, providing opportunities for businesses to locate or expand in Lea County. The regions strategic location, favorable business climate, and abundant natural resources have attracted a steady influx of businesses.

EnergyPlex Park

9,600 acre industrial park located North of Hobbs close to amenities such as hospitals, Zia Park Casino, 30+ hotels, two higher education facilities, and rail transportation

Hobbs Industrial Airpark (HIAP)

Located on NM highway 18, adjacent to the EneryPlex Park, with a total of 3,000 acres with 1,000 acres for development. There is no zoning and HIAP is shovel ready for light industrial developments. There are incentives available for development at HIAP from The City of Hobbs.
